# Submit your Employer's Payroll Statement online

Use your WCB online account or the access code located on the top-right corner of your Employer's Payroll Statement (EPS) letter.

### Do you hire and pay a person and/or business to perform labour who is not carried on your payroll?

### If yes, the WCB defines them as a contractor and a worker of your business.

You are required to report anyone you pay to perform labour, or have contracted to provide services for you in Saskatchewan, who is not on your payroll (that is, does not receive a T4). Contractors may or may not have their own accounts with the WCB. If a contractor is not registered with the WCB when the work is completed, you will be charged premiums to cover the work they did for you. This labour may have been performed on your worksite or the worksite of your customer. A clearance letter can tell you what their status is with the WCB.

Clearances must be obtained on each contractor before payment is made to ensure they have fulfilled all obligations under *The Workers' Compensation Act, 2013.* Clearances may be requested by principals or contractors through a variety of methods: WCB online account, email or phone. Results are instant in most cases and our employer services staff members are available to answer any questions you may have.

### Contractors are used in all industries

### **Examples of contractors**



#### Restaurants

Individuals or businesses that clean the range hood, dishwasher, refrigeration systems, install/maintain/repair the fire suppression system or perform any other repairs or maintenance of the equipment, building or property.



#### Offices

Individuals or businesses that provide garbage or recycling services, lawn maintenance or snow removal services, plumbing or electrical services, or any other repair or maintenance to the equipment, building or property.



### Health-care providers or clinics

Therapists and other health-care professionals, lawn maintenance or snow removal services, plumbers, electricians, cleaners/janitors, etc.

## Simplify EPS reporting

You can now import contractors by uploading CSV files. For the template and instructions visit wcbsask.com/reporting-contractors.

All contractors hired by a principal, whether registered with the WCB or not, must be included in your annual EPS submission. Most of that work will already be done for you if clearances are obtained before a contractor is paid. All you'll need to do is confirm the totals are correct and you're done. Contractors or principals can request clearances on work that's been completed. To see what clearances have been requested for your account, sign into your WCB online account.

**Please note:** supply only contracts: if a contractor only supplies materials and did not provide any installation, this is considered a supply only contract. These amounts should not be reported.

Outworkers: a contractor who never comes on site. They work under a contract for service and they may submit an invoice for payment or no deductions (CPP, EI, etc.) are applied to their pay.

Effective Jan. 1, 2025, directors of a corporation are not considered workers and do not have automatic WCB coverage. However, they may be able to purchase optional personal coverage with WCB to be eligible for benefits if they are injured at work.
